Important information:

1. The Committee of Management (COM) for Tawapata South Incorporation (TSI), has the final say in all matters related to the scholarship.
2. Priority will be considered by the COM based on the merit and recognition of the applicants.
3. Funds will be disbursed by the TSI accountant directly to the successful recipients within a timely manner.
4. Successful recipients will be named at the Annual General Meeting (AGM).
6. Applications are limited to one person per financial year (1 April-31 March)
7. **Achievement details*** - Field of Merit/Recognition, Details of Achievement, Competition Level (if applicable) and Date of Achievement/Competition.
8. **Supporting Documentation**** - Proof of relationship to shareholder (e.g., birth certificate, family tree, endorsement letter), Evidence of Merit/Recognition (e.g., certificates, awards, letters of recognition) Evidence of completion Representation (if applicable), Bank account details.

Scholarship procedure:

1. The scholarship is decided annually, and applicants may apply on an annual basis
2. Applicants must forward a completed Scholarship Application Form to the COM Accountant for checking and approval by TSI COM.
3. All sections of the application form are to be completed in full. Incomplete forms or required documents missing will not be considered.
4. A maximum scholarship per application is set at \$1,000.00 otherwise scholarship amounts are at the COMs discretion and no discussion about applications will be entered into once the decision is made
5. Applications are considered at COM meetings. Applicants should receive a response within 5 working days of the decision.
6. On approval, payment of scholarship monies will be credited to the applicant's bank account in a timely manner
7. Applicants may be required to attend a future meeting of the COM to present back to the COM/shareholders about how the scholarship supported them
